Re: \$729,000 (General Fund) Healthy Futures for Foster Youth - SUPPORT

Dear Assemblymember Arambula and Senator Talamantes Eggman,

The undersigned organizations are writing to request your support for a budget proposal of \$729,000 General Fund (GF) to establish an Early Infant Supplement for expectant foster youth three months before the birth of their child.

Receipt of a prenatal income supplement is shown to reduce the negative maternal and child health outcomes of low birth weight and preterm birth while also increasing positive outcomes, including breastfeeding initiation. The effectiveness of this approach is one reason why California's CalWORKS program provides a monthly prenatal income supplement of \$47, starting in the fourth month of pregnancy.

Unfortunately, young people in foster care are not eligible for this benefit and the foster care system does not provide a prenatal income supplement. This group of young expectant parents face greater hurdles in preparing for birth than their peers. A 2019 report found that 20.7% of 17-year-olds in foster care in California who gave birth did not receive any prenatal care; 42.7% of their pregnancies ended in stillbirths or miscarriage.²

In 2018, Los Angeles County took steps to improve birth outcomes among expectant youth in foster care by establishing the Early Infant Supplement, which provides \$415 to expectant foster youth starting in their seventh month of pregnancy. To date, the Early Infant Supplement has been provided to 358 expectant foster youth. A formal evaluation has not been conducted, but county officials note an increase in prenatal care, access to parenting education, and improved preparation for the birth and the child including immediate needs and supplies including diapers, formula, clothing, blankets, cribs and more.

The current budget proposal would build on the approach taken by Los Angeles County by establishing a prenatal income supplement for all expectant parents in foster care in California, available three months prior to the birth of their child. The statewide Early Infant Supplement would be equivalent to the current Infant Supplement of \$900 per month and made available to custodial parents in foster care. According to data provided by the California Department of Social Services, this would assist approximately 270 youth annually.

California can do more to improve the health of youth in foster care and their children and support them as healthy, young families. Additionally, California incurs high medical costs related to maternal

mortality and morbidity, stillbirth, miscarriage, and complicated pregnancies. This budget investment will more than pay for itself in future savings. Extending a modest expenditure will promote healthy futures for foster youth.
