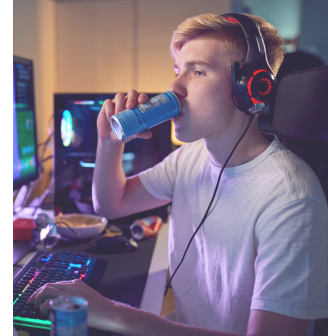


ADDICTION BORN OUT OF ACES AND THE RETURN OF HOPE
