

Policy & Strengthening Economic Supports



Policy & Strengthening Economic Supports Subcommittee

Supports equitable policy, systems, and environmental (PSE) change by identifying and prioritizing key strategies, such as implementation of existing state policies that strengthen economic supports for families and children [e.g. Paid Family Leave and the California Earned Income Tax Credit (CalEITC)], educating on the need for PSE change, and developing educational materials.

WHAT IS ACT?

- 3-year initiative funded by the Mental Health Services Act
- Building networks of people and places across the state that are working together to identify solutions that transform systems shaping child wellbeing
- Bringing together residents, youth, city officials and community leaders who know their cities best to co-design solutions
- **Healing** the adversities affecting all of California's children today and transform their future.



ACT Goals

Shape Perspective:

Onboard cities and help cities realize the essential role they play in public health efforts to address child wellbeing and trauma prevention. Cities work with community members and partners to identify their role and sense of purpose in promoting child well-being, preventing trauma, and advancing equity.

Innovate through Collaboration:

Cities network with one another to learn about other challenges, potential solutions and to create opportunities to strategize and learn together. These will be done through Learning Communities.

Shift Power:

Embed community voices into policy, planning, development, and city-wide, cross-sector systems improvement.

Sustainable Change:

Passing policies, creating strong programs, bringing in funding, and transforming systems so that children and families thrive.



THE STEPS

Engage communities across the state to participate

Help communities assess their data to understand the root causes of child and community adversity

Communities set goals, design a roadmap for success, and adopt plans for action

Through the ACT-CA network, communities learn together and develop new best practices for transformative change CHILD WELL-BEING



Team Leaders

Adult and youth community members - participate, spread the word, and help implement; promote and advocate for strong, healthy communities, children's health, and well-being and family focused solutions; ensure that policy changes are meeting the needs of community members and are sustained; hold decision-makers accountable; mobilize other community members; and are the voice of the campaign for social change.

Community-serving and youth organizations - increase community member awareness and participation in ACT; build trust and integrity with adult community members and youth; get feedback and input from adult and youth community members to improve processes or policies and advance efforts; and support active adult and youth community leadership (community activation) by creating conditions for large groups of community members to lead and be involved in transformational efforts.



Team Partners

City/County officials - are champions for ACT and have the power to push an agenda with City Council or Board of Supervisors; spark a call to action; adopt resolution and policy/policies; ensure they have an equity focus when providing resources and services within their community; and take intentional action to bring about social change.

Institutions/other - provide leadership and guidance; participate, help spread the word, and implement; ensure they have an equity focus when providing resources and services within their community; have a common goal and shared vision; and take action to bring about social change.



HOW IT WORKS



1. Establish a Core Team

- 2 or more residents
- 2 or more city officials/staff
- 2 or more Community-based representatives from organizations that advocate/create policy for child wellbeing
- 2. Assigned an ACT coach to help define an Action Area
- 3. Expand the Core Team to a Design Team of a broad representation of youth, community residents and organizations that support child wellbeing
- 4. Join a *Learning Community*



YOUTH DESIGN TEAMS



- Central to ACT is ensuring youth voices of the most vulnerable youth are heard
- Each city will have a Youth Design Team to inform the issues that will be addressed
- The Youth Design Teams create a leadership pipeline to better understand and promote policy changes



ACT Vanguard City: a city leading the way in new developments or ideas that are part of the ACT-CA Change Strategies. These are cities that may further ahead in the development stage.

ACT Pilot City: a city that is formally part of the ACT-CA Pilot. They will be recipients of TA provided by Coaches.

ACT Affiliate City: a city that is part of the broader ACT Learning Community. They may not be part of the initial pilot cities but are interested in the development of ACT-CA.



The ENGAGE stage is about cities becoming familiar with ACT, making a commitment to action, and formally joining the ACT Initiative.

Engage Stage Key Outcomes/Milestones:

- Cities align with ACT vision and values
- Cities/Design Teams commit to participate
- Cities/Design Teams conduct a community assessment
- Cities/Design Teams choose priorities/ North Star goals
- Cities adopts ACT resolution



The GROW stage helps cities select *Community Action Areas* and introduces cities to the *Learning Community* and *Data Dashboard*

Grow Stage Key Outcomes/Milestones:

- Cities engage in ACT Learning Community and Data Dashboard
- City Design Teams select and co-create Community Action Areas
- City Design Teams receive technical assistance and training associated with Community Action Areas
- City Design Teams develop implementation, evaluation, and sustainability plans



In the ACCELERATE stage, cities enact and implement policies and develop a sustainability plan which may include identifying additional funding support.

Accelerate Stage Key Outcomes/ Milestones:

- Cities continue to deepen connections within Learning Community
- Cities scale policies and programs for increased impact
- Cities measure outcomes of policies and programs
- Cities secure funding
- City Design Teams develop a sustainability plan

Funding: Request for Applications

The purpose of the **RFA** is to advance an ACT city's work plan goals by paying for personnel and program costs

- Not an "open RFA"
- Only ACT Pilot and Vanguard city teams can apply
- ACT Core Teams decide which Community-Based Organization (non-profit 501c3) should apply for the funds
- ~\$1 million fund

Stages and Phases of ACT

Stage 1: Engage

- 4 cities are in Phase 1
- 5 cities are in Phase 2
- 10 cities are in Phase 3
- 0 cities are in Phase 4
- 2 cities are in Phase 5

Cities have not yet reached Stage 2: Grow (**Phase 6**) or Stage 3: Accelerate (**Phase 7**)
