<u>Program / Community Partner Updates</u>

- ELCHC and Inclusion Support Services described seeing an increase in children with behavioral challenges and developmental delay.
- CBHC RFPs are posted on their website. There is an RFP focused on Trauma Informed Schools. The mandatory information session was held earlier in March 2023.

Brief Recap from Last Month

Prioritizing / Adding next step items following our discussion with Peace for Tarpon (January 2023) Items that seemed to surface to the top included:

• Implementing an Organizational Assessment of Trauma Informed Practice. Abraham identified how organizations can do it on their own terms. Additionally, a county, we can ask agencies to complete an anonymous survey. There could be 2 processes. One that is internal and can potentially lead to organization change. Another that is anonymous that gives a general picture. There are several tools / assessment / surveys in existence. Would we want to use the conference as a place to start an initial pilot?
