VI. Presentation: UniteUS

Dr. Eric Hazzard, Director- Network Development (SoCal and Hawai'i)

Dr. Moira Kenney, Regional Network Director- Western Region

Purpose: Addressing social needs has never been more important. UniteUs creates a network throughout California to send and receive electronic referrals that are secure, outcomes-driven, and focused on meeting community members where they are.

- UniteUs collaborates with partners across the community to make electronic referrals for health and social services, track client outcomes, and measure an organization's impact.
- Provides bi-directional referral systems, collaboration with existing systems, working alongside 211 and Community Information Exchange
- Operating system is open to smaller organizations, larger heath systems, and County systems
- How UniteUs does the work is intrinsically trauma-informed: A person will only need to tell their story once. It's all there on the platform (complying with privacy requirements)

Questions:

- How does this align or support CIE? Unite Us works alongside communities' existing 211 and CIE platforms
- How are schools and school district linked? Several school districts play a hub role on the platform. It is essential.
- How to serve non-English-speaking families? Platform uses Google translate for live translation of forms
- Are Asylum seekers included? Yes, would love to be connected with Refugee Network;
 Undocumented clients can be listed anonymously
- Sounds like CA-wide network. Concerns about client-confidentiality, consent and people who are skeptical about being in database. - There is a single consent form and clients can remove consent at any time.

- How are personal client information and services be protected for other organizations in the network? --Sensitive/Protected Service Types (food security, domestic violence service, etc.) are partition/masked from other organization. Currently onboarding Safe at Home as "sending only" organization
- How to include grassroots efforts? They have a team to support grassroots and volunteer organizations (i.e. NAMI statewide), keep the barrier a low as possible, can modify/customize role in platform to fit organizations needs.

VII. San Diego County Board of Supervisors

Racism is a Public Health Crisis in San Diego County

Dana announced that earlier this year the San Diego County Board of Supervisors voted 5-0 to declare "racism a public health crisis," passing policies to combat racism locally and create an equitable response to the COVID-19 pandemic. Chair Nathan Fletcher and Vice Chair Nora Vargas introduced the resolution to address systemic racism.

VIII. PACEs Connection Cooperative of Communities

Dana shared about the *Cooperative of Communities*, which is part of PACEs Connection. The Cooperative of Communities tracks the trauma-informed transformation of systems and organizations by County and across systems. The Cooperative of Communities tracks data on 14 Organizational Milestones (including Diversity, Equity, and Inclusion of a grass-roots, service provider, agency, and/or system's integration of trauma-informed, resilience-building practices and policies - Complete the 14 Organizational Milestones HERE.). Along with Dr. Nadine Burke Harris's Roadmap to Resilience, the intention is to reduce, by 50%, the impact of ACEs, in one generation. This county-wide database is one of two data bases tracked directly by the Office of Surgeon General. Further information about the 14 organizational milestones is attached to the minutes post.

San Diego County's Cooperative of Communities was funded by the San Diego Foundation's grant from Diane Johnson Legacy Fund. As an example, Dana shared the Fresno County Trauma & Resilience Network Community Tracker, Community Resilience Tracker (shinyapps.io) and Fresno Tracker (shinyapps.io).
