

Not to Be Forgotten

Intimate Partner Violence Homicide Victims (2020)

On March 29, 2020 **Natalia Uriarte (35)** was stabbed to death, allegedly by her husband **Francisco Uriarte (37)**, in their Chula Vista apartment. Francisco is currently at large.

On April 15, 2020 **Caira (15)** and **Leah Christopher (15)** were shot to death, allegedly by their mother's former boyfriend **Dwayne Edward Groves Jr. (38)**, when he came to their home in Lemon Grove and opened fire. The preliminary hearing for this case is scheduled for March 2022.

On May 29, 2020 **Natalie Horn (36)** received blunt force injuries, allegedly from her boyfriend **Ryan Dewling (35)**, in the apartment they shared in Coronado. Natalie died from her injuries two days later. The preliminary hearing for this case is scheduled for November.

On July 12, 2020 **Elizabeth Stolz (37)** and **Debora Stolz (65)** were shot to death in their Otay Mesa home by Elizabeth's former dating partner **Jeremiah Horton (aka Justice Love Peace) (31)**. Justice died by suicide later that day in Mexico.

On July 15, 2020 **Emily Cortez (19)** was shot to death, allegedly by her boyfriend **Jorge Manual Sanchez (18)**, in the apartment they shared in Mountain View, San Diego. The preliminary hearing for this case is scheduled for December.

On August 8, 2020 **Manuel Castro (41)** was stabbed to death, allegedly by his girlfriend **Anielka Arbizu (37)**, in the apartment they shared in Spring Valley. The preliminary hearing for this case is scheduled for October.

On August 11, 2020 **Kevin Powell (37)** was stabbed to death, allegedly by his husband **Daniel Scott Jordan (45)**, in their La Mesa home. The preliminary hearing for this case is scheduled for December.

On August 18, 2020 **Rhondda Dennis (89)** was shot to death by her husband **Dale Dennis (92)** in their vehicle in Carlsbad. Dale then died by suicide.

On August 18, 2020 **Mychael Farve (33)** was shot to death, allegedly by his girlfriend **Sheila Camarena (25)**, outside in the Talmadge area of San Diego. Sheila is currently at large.

On November 1, 2020 **Mayra Meraz (31)** was shot to death, allegedly by her boyfriend **Anthony Chaloux (42)**, in the home they shared in Valley Center. The preliminary hearing for this case is scheduled for December.

On December 14, 2020 **Judith Caruthers (72)** was shot to death by her husband Herman Hull Caruthers (74) in their La Mesa home. Herman died by suicide.

On December 22, 2020 **Rafael Choza (33)** was stabbed to death, allegedly by his girlfriend Shelley Reaves (52) in the apartment they shared in Escondido. The preliminary hearing for this case is scheduled for November.
