Update: Impact of the COVID Pandemic on California Children's Well-Being



Prior to the COVID pandemic, California ranked a dismal 35th nationally in children's well-being. Now, the ongoing public health emergency has exposed the already-frail infrastructure of supports for California's children and families and exacerbated the pre-existing disparities in our child-serving systems. Systemic racism is at the root of health, education, income, and other inequities, which have only deepened during this crisis. State leaders must take action to support children who have been impacted the most during this time.



ECONOMIC INSECURITY

Many Californians have had difficulty paying usual expenses, but households with kids fared the worst:

1/2 of households **with** kids had difficulty paying bills



1/3 of households without kids had difficulty paying bills¹

Latino children are more likely to have a caregiver in a sector highly impacted by COVID-related shutdowns.²

CHILD ABUSE & NEGLECT

Child neglect and abuse is going unreported, leaving kids in danger.

fewer calls to California child abuse hotlines in April-August 2020 versus April-August 2019, because kids are not in contact with teachers, doctors, and other mandated reporters.³



FOOD INSECURITY

In December 2020, 46% of California households with children didn't always have the food they wanted, compared to 35% of households without kids.⁴ Within these numbers, racial disparities in food insecurity persist.

PHYSICAL HEALTH



lower child vaccination rate in April 2020 versus April 2019, remaining too low today. This put out kids at risk for other infectious diseases like measles.⁵

MENTAL HEALTH

Children and parents are experiencing increased depression and anxiety due to pandemic-related school closures, isolation, and other concerns.⁶ Community trauma such as ongoing police violence can add to the stressors children face, especially Black kids.⁷



CONNECTION TO CARING ADULTS

Children are missing usual connections to caring adults like teachers, counselors, and child care providers.⁸ For example, low-income students were less likely to have access to in-person learning (see chart).⁹ Also, many child care providers have already gone out of business, or are in dire financial straits.¹⁰
