Dr. Sonkin will describe how attachment can offer insights into the causes of, and treatment for intimate partner violence. Daniel Sonkin, Ph.D. is a Licensed Marriage and Family Therapist in independent practice. Since 1978, his work has focused on the treatment of couples and individuals experiencing intimate partner violence. As one of the early specialists in the field, Dr. Sonkin has developed a widely-used protocol for treating perpetrators. He is an international speaker on domestic violence and the author of numerous publications.

- Participants will be able to describe how attachment theory broadens our understanding of healthy intimate relationships.
- Participants will identify ways in which insecure attachment can lead to intimate partner violence.
- Participants will be able to apply attachment-based interventions to reduce attachment insecurity with perpetrators and victims of violence.
