- All were welcomed, then individual introductions featuring newer members.
- Resource table included handouts and materials. Additionally, SCAC now has business cards for use at future events, such as tabling, outreach etc.
- Brief discussion regarding CPI as fiscal agent for SCAC group. Treasurer position vacant, Nancy has the related ledgers etc. Please contact committee if you will assume this position on Steering Committee.
- Considered the value and rationale for two SCAC members to attend the June, *Beyond Paper Tigers* conference in Pasco WA. Ideally, learnings from the conference could help inform our own efforts. Fiscally, we can cover the cost of registration and 2 nights/hotel. Unsure about the cost of airfare/meals.
- Mendocino shared data sets that may be of use and/or interest to others. Question: is SoCo specific data available in a similar format?
- The group inquired and reflected upon changes within the culture of those serving LGBTQ youth. As the
 movement around earlier intervention, surgery, etc. gains acceptance, there are concerns about
 potential long-term impacts if permanent decisions are made prematurely. This conversational inquiry
 sought to better understand the changing norms among those serving youth. More conversation
 necessary, as we all seek to deepen our awareness and understanding of changing social norms and the
 implications for youth.
- We met Elizabeth G. Vermilyea, Ph.D. the new Deputy Director of Child Parent Institute who brings 28+ years experience in the "traumatic stress field", including a dissertation that focused on factors that contribute to "compassion fatigue". She is new to Sonoma County and seeks an affordable rental/home. Please let her know if you have any leads!
- Bryan Clement, Ex. Dir. of DoveTail Learning; "Tool Box", shared his notes from a Marin workshop during
 the April, Prevent Child Abuse campaign. Vilma Reyes, PsyD. presented on Trauma -Informed Care:
 "Providing relationship-focused, culturally-informed interventions for trauma-exposed young children
 and their families". *For details, please see his notes.
- Emilio Licea, PsyD, from West County Health Centers described substantial Genetec funding to work with the *Resilient Beginnings Collaborative/Center for Care Innovations*. Focused primarily on 0-5yo population, they are also supported by Guerneville Elementary School. Goals include 1) becoming a trauma-informed organization, 2) Implementation of PEARLS screening with children and possibly parents, 3) collaborate with key community stakeholders (including participating in SCAC meetings!) Following a site visit from Nadine Burke Harris, they learned that the implementation of the ACEs screening will be pushed back to January 2020. At the state level, initial training will focus on providers, although there is awareness that front line staff would also benefit.
- Several WCHC staff, including those impacted by the fire and the floods, were able to participate in the trainings. Since then, staff have utilized some of the tools, to self-regulate and modulate stressful experiences.
- Among FQHC sites, (or healthcare centers in general) WCHC has nearly a 1:1 ratio of behavioral health staff to medical staff. It is great seeing staff utilize the skills they developed at the trainings.
